Supervisor Gilliam: The roof on the building next door to Town Hall is having the roof replaced. Supervisor Gilliam asked the Town employee to be patient with the process. He stated that they should be completed by Wednesday, August 21, 2024.

Shelby Taylor: Ms. Taylor stated that she is appalled by the appearance of the Town Cemetery. She has two plots at the cemetery. The cemetery needs attention. It is in very poor condition and needs attention as the grass is knee high. She suggested the Council could ask for donations for the Cemetery Fund. Perhaps ask the person responsible for cemetery upkeep to cut the grass later on in the week; perhaps on Friday.

Rural Planning Caucus: Dennis Carney, Consultant, would like to attend the caucus. A motion was made by CM S. Moss and seconded by VM Baker to approve Mr. Carney attending the caucus. All others: Aye. The motion carried.

Council Salaries: The annual pay for the councilmembers and mayor are drastically behind the times. The salaries need to be doubled in order to be comparable. A motion was made by CM Venable to raise the Council double the amount that they are currently paid (CM \$250 to \$500 and Mayor \$600 to \$1,200). The motion was seconded by VM Baker. All others: Aye. The motion carried.
